ENERGY-EFFICIENT TECHNOLOGIES LEAD TO LONG-TERM SAVINGS

Energy-efficient technologies can lead to long-term savings on maintenance, natural gas, utility bills, and other associated carbon costs. Investing in your building can also help you stay ahead of the curve, grow your business, and streamline your operation. It can also increase the reliability of your facilities and enhance occupancy comfort.

To compliment a high-efficiency boiler, you can also receive incentives for qualifying:

- ▶ Boiler or heater controls that optimize boiler operations based on demand
- ▶ Economizers that recover waste heat from hot flue gases and reuse it to heat incoming water
- ▶ Vent dampers that help avoid energy loss when the boiler is not operating
- ▶ Pipe insulation that keeps pipes at a steady temperature
- ▶ and more.

From water heating to HVAC, there are plenty of ways to take advantage of energy-efficient boiler systems.

Based on common applications, participants can expect to:

- ▶ Receive incentives of up to 50% on replacement boilers
- ▶ Receive incentive payment four weeks after final approval
- ▶ See energy savings equivalent to your investment within 3 to 10 years*

*For example, in a 50,000 sq. ft. facility, to install a 2,500 MBH high-efficiency boiler you can expect to pay approximately \$150,000 for equipment and installation, receive \$30,000 in incentives, and realize savings for at least 15 years. Payback for the additional cost spent on a higher efficiency boiler (compared to a standard-efficiency boiler) occurs within less than 3 years.

SAVE EVEN MORE WITH THE ESB PROGRAM

The ESB Program offers incentives to eligible Alberta businesses and non-profits to choose proven high-efficiency products—such as boilers—and onsite energy generation technologies that meet their needs.

- ▶ Incentives of up to \$250,000 are available per project
- ▶ Up to \$1 million per parent company.
